### 3. Currency conversions

1. If the contract partner submits a card transaction to Nexi in a currency (transaction currency) for which Nexi has no settlement account, Nexi converts the card transaction from the transaction currency into euros. If the contract partner has agreed with Nexi that card transactions are to be credited in a currency (credit currency) for which Nexi has no settlement account, Nexi converts the card transaction from the transaction currency or – if the card transaction was converted from the transaction currency into euros in accordance with sentence 1 – from euros to the credit currency. Sentences 1 and 2 apply accordingly for chargebacks and the debiting of credits, whereby the currency conversion takes place in the reverse order, to the extent that the corresponding currencies are not identical.
2. Currencies are converted on the settlement date. The settlement date for Mastercard, UnionPay, JCB, DCI and Maestro is the calendar date before the card transaction was submitted, the chargeback is debited or the credit is submitted. The settlement date for Visa and V Pay is the calendar date after the card transaction is submitted, the chargeback is debited or the credit is submitted.
3. Currencies are converted on the basis of the Nexi digital exchange rate table. This is published under [www.nexigroup.com](http://www.nexigroup.com). The settlement rates are calculated on every working day from 8 a.m. Changes to these exchange rates take effect directly and without any prior notification of the contract partner.

All fees are subject to German VAT at the statutory rate.
